Service Description

Silver – One scheduled Posh Pup service monthly on 1st, 2nd, 3rd or 4th of whichever day of the week your scheduled time is on.

Gold – Two scheduled Posh Pup services monthly on either the 1st and 3rd or 2nd and 4th of whichever day of the week your scheduled time is on.

Platinum – Four scheduled Posh Pup services monthly on the 1st four of whichever day of the week your scheduled time is on.

The Posh Pup Package service includes: Transportation from your home* at the above member address to our salon at the above listed address and back to your home, the dog will be brushed out, receive a relaxing massage bath with all natural shampoos, conditioner massaged in to the coat, hand drying with chamois and cotton towels, blow dry by hand, nail trim, a bandana and an after bath treat**.

* Package price will vary depending upon 'zone' or area of town home is located in.

** Please notify us in writing if your dog can not have treats.

Terms, Conditions, Notices & Disclosures

These services will be scheduled on an ongoing monthly basis. Ex: Gold may be scheduled for 1st and 3rd Wednesdays or Platinum may be scheduled on the 1st four Thursdays of the month, etc. Rescheduling must occur at least 24 hours prior to appointment time to avoid a missed appointment fee of \$25. A \$50 fee will be charged if the appointment is not cancelled and the driver comes to the above member address for a scheduled pick up. The appropriate fee will be charged to the same credit card that the monthly fee for the Posh Pup Package is charged to on the day of the missed appointment. Payment for services will be charged to the credit card listed below on the first of the month in advance of the services. Relocation or change of pick up address to another 'zone' or area of town may increase or decrease the amount of the package price.

Requests for services not listed in the above description of the Posh Pup Package may result in an extra charge. You may request additional services by phone and will be told of any extra charges at the time of the call. By signing this contract, you are agreeing to pay the additional charges for the requested services which will be charged to the same credit card that the monthly fee for the Posh Pup Package is charged to on the same day that the requested service is rendered.

This contract commences on the date in the bottom left hand corner and may be terminated at any time with a 30 day written notice. A member in good standing may freeze the membership for a 30 day periods only – no partial monthly freezes are permitted, however, the member may freeze the account for consecutive 30 day periods and pay for the additional appointments desired at the regular rate for a one-time service.
